POLICIES AND PROCEDURES

<u>Policy No:</u> 007-2 Liens on Property Due to Non-payment of Assessments.

Policy: It is the policy and responsibility of JLPOA Board of Directors to uphold

the Covenants, Conditions and Restrictions (CC&R's), Design Standards, and the By-Laws as recorded in the State of Florida, County Court House

of Brevard, on October 24, 1994.

Procedure:

- Assessments are due for payment on January 1st of each year, and become past
 due on January 31st of each year. On February 1st of each year, reminder letters
 are sent out to residents who have not paid their assessments (Attachment A). A
 late charge of \$5 per month is accrued until the assessment is paid in full or a lien
 is filed.
- On March 1st of each year, a letter of Intent to Place a Lien is sent out (Attachment B). In accordance with Florida State Law, interest accrues at 18% per annum if a lien is filed.
- On April 1st of each year, a lien is placed on every residence that has not paid the assessments in accordance with the CC&Rs. This takes place as follows:
 - The lien is typed up (Attachment C), and filed with the Brevard Clerk of the Court by the board member responsible. The lien will be given a file number and placed on public record.
 - The original document containing the file number and date is given to the JLPO Secretary to be placed in the file for the home address.
 - A copy of the lien is forwarded to the property owner
 - A copy is placed in the active lien file for easy retrieval when further action is required.
- Upon payment of the assessment a Satisfaction of Lien (Attachment D) is processed as follows:
 - The board member responsible will file a Satisfaction of Lien (Attachment D) with the Brevard Clerk of the Court.
 - The payment should include filing fee, late charges, interest accrued and the fee to remove the lien.
 - A copy of the Satisfaction of Lien is sent to the homeowner.
 - The original Satisfaction of Lien is given to the JLPO secretary to complete the file for the home address.
 - The lien is be removed from the active lien file.

- If the lien is not paid, it will remain on record with Clerk of Brevard County Circuit Court where it will continue to accrue interest at 18% per annum.
- If the property goes on the market for sale, the closing agent will find the lien on file with Brevard County Court House and the sale will be held up until the lien is paid.
