MINUTES

CALL TO ORDER:

Dee Anna called the meeting to order at 6:30 p.m.

APPROVAL OF MINUTES:

Treasurer – Carol reports on bank balance as of the end of April and the CD balances.

ARC – Dee Anna reports there have been several applications since the last meeting.

Management- Sara reports the last inspection was performed and letters send. The 2022 Taxes were filed in proper time.

Management will confirm that Ground Professionals is spraying to help reduce growth in the common natural areas; DeeAnna will speak with the homeowner.

Karen discusses the problem with solicitation in both mailboxes and dropped onto driveways.

2866 Sebastian is a problem rental owner by an investment company. A final letter will be issued if not done yet.
